## AUTHORITY TO REPRESENT

RE: McMinn County Commission civil suit against those legally responsible for the wrongful distribution of opioids in McMinn County and damages caused thereby.

The McMinn County Commission is a public entity which may sue and plead in its own name. The McMinn County Commission is vested with the power to superintend the administration of the internal policies, programs and affairs of McMinn County. A county commission only has powers expressly conferred by the Tennessee Constitution and our State Legislature, or powers reasonably and necessarily implied for exercise of those expressed powers.

The McMinn County Commission authorized the retention of and directed James F. Logan, Jr. and the law firm of Logan-Thompson, P.C. and Thomas Jessee, a member of the law firm of Thomas C. Jessee, LLC d/b/a Jessee & Jessee Attorneys, Crystal Jessee d/b/a Jessee Law Office, to pursue <u>all\_civil</u> remedies against manufacturers and all entities in the chain of distribution of opioids.

In consideration, the McMinn County Commission agreed to pay one third (33 113%) of the total recovery (gross) as an attorney fee whether the claim is resolved by compromise, settlement, or trial and verdict (and appeal). There is no fee if there is no recovery. The McMinn County Commission acknowledged that this fee is reasonable given the anticipated time and labor required, the novelty and difficulty of the questions involved, the skill requisite to perform the legal service properly, the likelihood that the

acceptance of the particular employment will preclude other employment by the lawyers, and the experience, reputation, and ability of the lawyer or lawyers performing the service.

The law firms agreed to advance all reasonable and necessary litigation expenses to prosecute these claims including any discretionary costs that may be taxed against McMinn-County. All such litigation expenses will be deducted from any recovery after the contingent fee is calculated. There is no reimbursement of litigation expenses if there is no recovery. The division of fees, expenses and labor between the law firms will be decided by private agreement between the law firms.

The McMinn County Commission authorizes James F. Logan, Jr. and the law firm of Logan-Thompson, P.C. and Thomas C. Jessee, LLC d/b/a Jessee & Jessee Attorneys, and the Jessee Law Office to retain other counsel to participate in the just prosecution of this case. In no event will the fee charged be increased by the addition of other counsel and the division of such fees shall be determined by private agreement between the law firms. If the council does in fact retain other counsel to participate in the prosecution of this case this contract may be amended to reflect the names of the counsel that will be working with the undersigned in this matter.

James F. Logan, Jr. and the law firm of Logan-Thompson, P.C. and Thomas C. Jessee, LLC d/b/a Jessee & Jessee Attorneys and the Jessee Law Office shall keep the McMinn County Commission reasonably informed about the status of the matter in a manner deemed appropriate by the Client. The Client at all times shall retain the authority to decide the disposition of the case and maintain absolute control of the litigation.

Upon conclusion of this matter, James F. Logan, Jr. and the law firm of Logan-Thompson, P.C. and Thomas C. Jessee, LLC d/b/a Jessee & Jessee Attorneys, and the Jessee Law Office shall provide the McMinn County Commission with a written disbursement statement stating the outcome of the matter and, if there is a recovery, showing the remittance due to the client and the method of determination of the same before any monies are disbursed from the recovery.

Nothing in this Agreement and nothing in the Attorneys' statement to the Client may be construed as a promise or guarantee about the outcome of this matter.
