- Mayor Gentry said they have called a meeting that will include the County Commission, E911, AMR and the Emergency Director for Starr Regional Etowah and Athens and will have a follow up meeting with the county commission after this meeting.
- Michael Bobich Interim Operations Manager for AMR, filling in for Jamie Nichols who is out due to family sickness. Mr. Bobich spoke about some of the incidents Ms. Lyons voiced her

concerns about and assured the county commission that the ambulance service is staying within 10 minutes of each call. He also said Tom Trotter with E-911 has call logs to show this. Mr. Bobich answered various questions from the county commission.

• Mike Carpenter spoke with the commission about County Road 323. He brought pictures to show mud and other hazards on the road he believes is coming from the junk yard business there (Woodrows). Mr. Carpenter stressed his concerns for his family and anyone else that has to use this road. He wanted to know who is responsible for all the mud on the road. Mayor Gentry said he has spoken with Commissioner of Highways Dan Evans about this situation and also ask his assistant Mark Cochran to be looking at some private acts that might help. Mayor Gentry also told Mr. Carpenter to come to his office on Tuesday and they would make some phone calls to some different agencies to try and get some help with this issue.
