13. COMMENTS FROM THE COUNTY MAYOR

Joint meeting County Commission & School Board.

Mayor Gentry said the meeting will be to look at a presentation from the architect that was discussed in a prior meeting. The meeting will be at the School Board on Monday January 31, 2022 at 6:00 pm.

Resolute.

Mayor Gentry said this Wednesday and Thursday there will be a job fair at the Resolute plant with 40 industries from various places to help place the employees who are losing their jobs.

American Rescue Plan.

Mayor Gentry said the Budget Committee discussed the ARP funding. He said that by January 30th they have to turn in that report and the Budget Committee did recommend that the last final ruling from treasury that changed a lot of the eligibility to what the projects were for the first 10 million. Now there is kind of a blanket to do what you need to do and still has to be spent by December 2026 but you don't have all the different requirements as before. A new allotment of about 10.5 million the committee recommends will go toward covid projects for the school systems.

McMinn Higher Education.

Mayor Gentry said they had their first executive committee meeting with the Higher Education Center just to make sure everything is moving along smoothly. They did a satisfaction survey of their students and had a 96% satisfaction.
