8. <u>RACHEL SWAFFORD – TN DEPARTMENT OF HEALTH – MCMINN COUNTY HEALTH UPDATE</u>

12. REPORTS FROM COMMITTEES, COUNTY OFFICIAS, COMMENTS FROM COMMISSSIONERS

Chairman Curtis said they had talked about changing the time that the County Commission meets each month from 7:30 pm to 6:00 pm. Commissioner McPhail made motion to change meeting time to 6:00 pm, seconded by Commissioner Slack. Motion carried by voice vote.

13. COMMENTS FROM THE COUNTY MAYOR

- Mayor Gentry welcomed Tony Richeson who has been chosen by AMR to be the new local county director of EMS replacing Jamie Nicholson.
- Mayor Gentry said the Etowah/Englewood Ambulance station next project meeting will be October 26, 2023 and should be 95% completion of renovation of that station.
- Mayor Gentry said they had a pre-bid meeting last week on runway lighting replacement project and next week they will be opening those bids.
- Mayor Gentry said on the Hanger Designs they are finishing up on the pre-engineering on the new hangers and many know the hangers to the left on the south end of the runway those will be taken down eventually but are building replacement hangers first.
- Mayor Gentry gave an update and the City of Athens Animal Shelter update. McMinn County contributed \$250,000 to that project and are hearing completion is expected late February/early March 2024.
- Mayor Gentry wanted to bring everyone up-to-date on a new project which would offer CDL training and Lineman training. He said they have been in discussions with Cleveland State and TCAT on developing a CDL program and a Lineman's program. He said they received a letter this week that they are committing to provide both those intuitions the training CDL's locally and the Lineman's training and will be looking to McMinn County and City of Athens for a facility. He said they are meeting next week with everyone.
- Mayor Gentry gave an update on Mt Verd Industrial Park. He said they were approved for a sight development grant of 2 million dollars and will be partnering with the city on that and it will go out for request for qualifications this week for that site development.
- Mayor Gentry said the landfill has a new engineer. He said they voted a couple months ago for modification for existing footprint and see what they can do to maximize airspace. Which that process has began as well and will be an 18-to-24-month process. Mr. Gentry said they are not expanding the landfill.
- Mayor Gentry gave an update on the progress for the new Health Department. He said they were notified that their procurement of architectural firm was approved by the state last week and are now looking at 3 different site locations.
- Mayor Gentry said November 14-16 2023 a group called Fam Tours will be coming in kind of like a third party looking at our community and doing personal interviews on what we can do more efficiently with our hotel/motel tax to attract more business.

- Mayor Gentry said the Opioid Council had had their first meeting and are developing an application and hopefully have that to come back before the committee.
- Mayor Gentry said the survey at Camp Cherokee has been ordered. He said the survey will be more than \$20,000 but they must know the boundaries from all the different years before they can do the next project. Mr. Gentry said the County Forestry has its own funds with over \$110,000 in it. Melinda King, McMinn County Clerk said there is over \$120,000 in the fund now.
