WHEREAS, the McMinn County has systematically been upgrading its hangar facilities, with only 3 of the original structures remaining; and

WHEREAS, the 3 hangars are to be demolished/removed due to the hangars having been identified as violations of the PART 77 surfaces. The taxiways and aprons serving these hangars are violations of the runways OFA, however the grade deficiencies and violations cannot be addressed due to the need for the hangars. Due to these deficiencies, the State and FAA have been moving to relocate the hangars and reconstruct these pavements for many years as opposed to expending funds on pavements that cannot meet geometric safety standards. These asphalt surfaces are now well over forty (40) years old; and

WHEREAS, this Commission was previously approved for a grant to conduct preliminary design for the replacement hangars in 2021; and

WHEREAS, two separate grants will be required to complete the project; one for final design thru bid and one for construction; and

WHEREAS, the grants will be on a 95-5 precent match formula; and

MCMINN COUNTY FOREST AND REGIONAL SHOOTING MASTER PLAN 2024 ARC APPLICATION

WHERES, McMinn County has been approached by the Tennessee Wildlife Resources Agency regarding the potential location of a regional shooting range in the McMinn County Forest; and

WHERES, TWRA has Pittman-Robertson funding available from U.S. Fish & Wildlife to grant the construction and/or maintenance of shooting ranges; and

WHERES, the McMinn County Regional Forest is a large 288-tract where the McMinn County Forest Association has been responsible for implementing a forestry management plan and advising the county on appropriate uses of the property; and

WHERES, a 25 acre portion of the property is home to Camp Cherokee, a summer youth camp, operated by the McMinn-Meigs Association of Baptist, and

WHERES, McMinn County is interested in the additional revenues that a regional shooting range would create as well as supportive of competitive high and collegiate sports activities that could occur at McMinn High School and Tennessee Wesleyan University with access to such a facility; and

WHERES, the McMinn County Forest located adjacent to the Hiwassee River is prime for the development of additional outdoor recreational uses such as canoe and kayak access as well as the development of wildlife viewing areas, picnicking, and hiking and biking trails.

WHERES, McMinn County wants to complete a comprehensive Master Plan which includes meeting all the environmental requirements, public engagement and ensuring appropriate stewardship of the natural resources; and

WHERES, The Appalachian Regional Commission (ARC) has grant funds available to assist with developing a comprehensive Master Plan for the property to accommodate all existing uses of the property as well explore better utilization of the of the natural resources and asset; and

WHERES, McMinn County has been invited to apply to ARC for \$350,000 in grant funds for assistance with the development of this Master Plan with a required local match of \$350,000; and

WHERES, to the extent possible, McMinn County will use TWRA funding assistance for the regional shooting range as matching funds.

BE IT THEREFORE RESOLVED by the McMinn County Commission that the County Mayor is authorized to submit an application for up to \$350,000 in ARC funds for the McMinn County Forest and Regional Shooting Range Master Plan and hereby commits to the matching funds as required by the grant.

BE IT FURHER RESOLVED that the County Mayor is authorized to enter into any agreements necessary for the successful award of the grant, subject to its approval by the funding source.

NOW HERETOFORE, if said ARC application is approved, the County Mayor is hereby authorized to accept on behalf of McMinn County, execute any and all documents and enter into agreements necessary for the successful application and award of the grant and to enter into a project administration agreement with the Southeast Tennessee Development District, subject to approval by the funding source.

11. REPORTS FROM COMMITTEES, COUNTY OFFICIAS, COMMENTS FROM COMMISSSIONERS

Commissioner McPhail said the Airport Committee met tonight and he will let the County Mayor give an update on what was discussed in his comments.

12. COMMENTS FROM THE COUNTY MAYOR

Mr. Gentry gave an update on the airport. He said the county is in the middle of the airport layout plan about 30%. Which should be done every ten to twelve years and did get a grant to do that. He said the timing on that is good since Swift Museums recent action to expand their facility and willing to give a large portion of their original land lease for further development behind the airport for additional hangar space for the future. Mr. Gentry said he will be asking County Attorney Tim Hill to make a quick addendum for that and will be presenting it to the commission soon for consideration. He said this is perfect timing for ALP to announce and incorporate all that area for future development.

Mr. Gentry said they have an option for the hangars looking at replacing the county has been invited after action taken tonight and will go to Nashville and present request for final designs to the aeronautics committee to get that project going. He also said the demolition will probably be done inhouse and will bid those out.

Update on the runway lighting, the materials have been submitted and we are waiting on them to be delivered.

Mr. Gentry said to mark your Calanders for March 1st planning session. Usually done at 5 hoping to start this year at 4 due to some recent retirements. Session will be at the Etowah Depot in the newly renovative Portico Room. He said a big portion of the night will be with tourism group who will be here from Nashville.

Government day on March 19th-20th.

Mr. Gentry said they have received their last settlement from the Opioid Council that came in last week that was from the Food City settlement and have a full slate of funds that we can now program and get that group together this month and go forward to get those out to the public.

Mr. Gentry said the Woods Foundation has met and they put out a proposal which they received 9 proposals for the Woods Foundation Funding. They have \$75,000 to allocate which the request came in at right

at \$80,000. He said they meet on the 15th and come out with a recommendation for the commission at the next meeting to fund those suggestions from that. He said they had good interest this year for that fund and look forward to doing that.

Mr. Gentry gave an update on the Health Department. He said the surveyors have been here and are developing a proposal to bring back to the commission on the property and a title search in being done. He said they had to get some testing done on the property and go back and forth with the owner. Mr. Gentry said hopefully will have that for the next meeting to come back with a sales contract for the commission to consider for that site. He said after speaking with the State Department of Health they have said some other counties have not used their monies and have no plans to use it. So, they are looking at possibly increasing the amount of money for McMinn County for that new facility. He said he thinks they might ask the county to bid it out first to see what they need.

Mr. Gentry said on the Landfill they are working on major modification on the C and D side. The LIDAR survey is being completed. The Volumetrics is now being preformed and should have that hopefully by the end of this week and Core drillings have been scheduled for the end of this week and go from that and do Hydrology studies. They will do that for the expansion of our current sale on the C and D. Mr. Gentry said they will have a Landfill Committee before next month's meeting to go over all these results and hopefully they will be in by then.
